- Approval of the Minutes of the November 13, 2018 Transportation Technical Committee Meeting.
 Mr. Morlok requested a motion for approval of the November 13, 2018 minutes of the Transportation Technical Committee. Mr. Kammler motioned to approve the minutes as written. Ms. Ernst seconded, and the motion carried.
- 2. <u>Status of Project Progress Report</u>. Ms. McCullough noted that FFY2018 projects will be added to the progress report in the new year. She asked the Committee to send updates to the progress report for project tracking. Updated progress reports are posted following the Technical Committee meetings at:

 http://bistateonline.org/index.php/transportation/quad-cities-metro-planning/2012-11-13-20-10-34/quad-cities-metro-tip-transportation-improvement-program. No jurisdictions had additional updates to share at the meeting.
- 3. <u>Discussion and Consideration of Surface Transportation Block Grant (STBG) Evaluation Manual Update.</u> Mr. Morlok noted that the agenda item was tabled from the last meeting to allow for Committee review of the STBG Evaluation Manual Update. Ms. McCullough noted that there were no comments received prior to the meeting and the key items revised included the addition of Iowa's Swap Policy program and addressing the eligibility of engineering for federal funds based on the Illinois DOT District 2 policy. The pavement conditions and safety criteria were adjusted to align with the federal performance measures. There was an inquiry on the next round and the programming year the round would include. Ms. McCullough indicated that subject to the Technical Committee recommendation and Policy Committee approval proposed for January, a STBG round could be solicited in February with awards in the April/May timeframe. Mr. Kane motioned to recommend the update manual for approval to the Policy Committee. Mr. Statz seconded the motion, and it carried.

- 4. Presentation on Quad Cities Extreme Weather Pilot Program. Ms. McCullough outlined a two-year pilot project as part of a grant from the Federal Highway Administration. The purpose of the project is to assess types of extreme weather that are probable and to determine vulnerable transportation assets in the Quad Cities that might be subject to extreme weather. A kick-off meeting was held on November 13 with an advisory group. Another meeting will be held in March to share the status of data collection, followed by a workshop to determine transportation assets that could be potential hot spots. The next step is to develop and launch a transportation stakeholder survey of known vulnerable facilities and begin to collect information from a multi-modal system approach. Status reports will be given to the Technical Committee as the pilot project progresses. It was suggested that the Coast Guard be included in the outreach, as well as the traffic safety committee.
- 5. Public Comments. No public comments were made.
- 6. Other Business. The next meeting will be held on January 8. Mr. DeLille noted that the MPO will need to affirm the state safety targets or approve MPO-level targets. This will be included on the January agenda.
- 7. <u>Adjournment</u>. Mr. Anderson motioned to adjourn the meeting. Mr. DeLille seconded, and the meeting was adjourned at approximately 10:40 a.m.
