RE: Request for Surface Transportation Block Grant (STBG) Program Candidate
Projects for Evaluation Process in Iowa Quad Cities Metropolitan Planning
Area

A Surface Transportation Block Grant (STBG) Program, formerly known as the Surface Transportation Program (STP), solicitation is being initiated to program the Iowa Quad Cities STP/STBG targeted funds through 2021. **In the Iowa Quad Cities, the estimated funds to be programmed are \$15,966,759.** Annual funding targets for the Iowa Quad Cities are estimated at \$3,784,000 based on the federal Fixing America's Surface Transportation (FAST) Act dollars.

Bi-State staff encourages other persons receiving a carbon copy of this notice to work with their respective local governments on potential candidate projects. Noted below are details on funding availability, project eligibility and sponsors, costs and match, process, and the deadline.

Funding Availability

Estimated funds to be programmed are based on the remaining balance to the Iowa Quad Cities in STBG monies, estimated target funds, minus all previously programmed funds. Funding levels may be subject to availability through federal appropriations and subject to modifications with the reauthorization of the transportation act, known as Fixing America's Transportation System, FAST, which is authorized through 2020. Beyond Federal Fiscal Year (FFY) 2020, funding levels are assumed at the current levels based on an expectation by the Federal Highway Administration (FHWA) that programming should reflect anticipated projects within a four-year Transportation Improvement Program.

Project Eligibility and Project Sponsor

A candidate project submittal form is enclosed and may be copied for multiple submissions. **Eligible projects must be identified in the 2045 Long Range Transportation Plan for the Quad Cities.** The plan is available online: <http://bistateonline.org/transportation/quad-cities-metro-planning/2012-11-13-20-19-45/quad-cities-metro-lrtp-long-range-transportation-plan>. Refer to Chapter 7 *Projects and Price Tags*, Tables 7.3 and 7.4 for a listing of roadway projects. Other eligibility requirements are in the STBG Manual accompanying this memo.

Transportation projects must be located on the federal functionally classified system (collector or higher functional classification) to be eligible or identified as an exception in the STBG Manual. Projects must be sponsored by state and local governments or transit systems, as designated by the Iowa DOT.

STBG funds can be used for any mode of surface transportation – roadway, transit, pedestrian, or bicycle facilities. Under FAST, these eligibilities remain.

Project Cost Estimates, Matching Funds, and Minimum Project Cost

Project costs should be estimated in Year of Submission Dollars (CY2017) with an estimated construction year and a rate of inflation used by your jurisdiction to estimate Year of Expenditure (YOE). YOE is expected to coincide with FFY 2018, 2019, 2020, or 2021. Please note the anticipated program year in your application. A procedural checklist is available in the STBG manual, page 2-7. The manual is posted online at <http://bistateonline.org/transportation/quad-cities-metro-planning/2012-11-13-20-10-34/project-programming-processes>.

The STBG funds are required to be matched with at least 20 percent and not more than 50 percent non-federal funds. Projects must have a total project cost no less than \$125,000, as the federal-aid process requires considerable administration on the part of the project sponsor.

Process

The Quad Cities MPO Transportation Technical Committee ranks candidate projects and recommends programming to the Transportation Policy Committee in accordance with the manual noted above. Recommendations and selection of a project(s) will occur at Technical and Policy Committee meetings in April and/or May 2017, respectively. Notice of these meetings will each be sent at least one week prior to the meeting date.

Deadline

Candidate project submittals are requested by Friday, March 3, 2017 by 4:30 p.m. No projects will be accepted after this date.
