## Seeking Public Comments on Transportation in the Quad Cities for 2050


Connections are important to business and our community. Having a reliable, efficient, and convenient way to get places to make those connections is vital to our health, happiness, and prosperity. Every five years, the Quad Cities Long Range Transportation Plan (LRTP) is re-evaluated. The update process looks at changes in our transportation system and economy, and future trends.

To aid the planning process, Bi-State Regional Commission is conducted two open houses to kick off the public input process for the LRTP. These February 2020 meetings were used to gauge public opinion on how our roads, buses, and other travel infrastructure meet area mobility demands. More input is desired. Public input will help shape the future of the Quad Cities Area transportation system.

## Public Input Opportunities

The Quad Cities Transportation Policy and Technical Committees oversee plan preparation. These committees are made up of local elected officials and technical staff. In the next year, they will work with Bi-State staff to prepare a full draft update by early 2021. The update will include transportation goals and a collection of existing and proposed transportation system recommendations.
