- 1. <u>Approval of Minutes of the August 23, 2022 Quad Cities MPO Transportation Policy Committee Meetings.</u> Mayor Gallagher, sitting in for Mayor Matson, requested a motion to approve the minutes. Mr. Ortiz motioned for approval of the minutes as written. Mr. Dunn seconded the motion, which carried unanimously.
- 2. Update on I-74 Mississippi River Corridor Reconstruction. Information was shared by Mr. Wu based on an e-mail summary from Mr. Wick who was unable to attend. Demolition of the old I-74 bridge began in September 2022. Deck removal was slated for the week of September 26. The majority of the bridge will be dismantled in sections. To minimize impacts on river traffic and environmentally sensitive areas, explosives will only be used in select locations. Demolition is expected to be complete by mid-2024. In Bettendorf, reconstruction of 12th and State Street is nearly done with finishing of sidewalks and landscaping underway. The road is open, and work should be complete by the end of October. Progress is being made for landscaping both in Moline and Bettendorf in the downtown areas of the project.
- 3. Consideration of Revisions to FFY2022-2025 and FFY2023-2026 Transportation Improvement Program (TIP). Ms. McCullough directed the Committee to the agenda packet to 18 amendments submitted by the Illinois Department of Transportation and one from Davenport CitiBus. Illinois DOT approved the state's five-year transportation program after the adoption of the Quad Cities MPO FFY2023-2026 TIP. For the ILDOT, a number of projects were changes in funding, 11 for new projects and one deletion. CitiBus received a federal grant for 4 new electric buses and charging infrastructure as part of the No-Lo program for emission reductions. Mr. Ortiz motioned for their approval as presented, and Mayor Freeman seconded. The amendments were approved. Ms. McCullough also directed the Committee to a dozen administrative modifications submitted from ILDOT that were planned for advance construction or shifting fiscal years. No action on these projects was needed, and they were presented for

information. A copy of the TIP amendments and administrative modifications approved at the meeting are attached at the end of the minutes.

- 4. Presentation on Iowa Department of Public Health (IDPH) Physical Activity Access Project. Mr. Schmid provided an overview of the IDPH, renamed to Iowa Department of Health and Human Services, physical activity access projects. The program goal is to increase opportunities for older Iowans with low incomes, who live independently, to be physically active in their neighborhoods and local communities. In year 4, projects in Buffalo, Iowa were highlighted. The project included walk audits, senior needs assessment, and pedestrian pop-up projects at two crosswalks on Dodge and Jefferson Streets. The funding allowed for planning activities and projects that would be considered temporary, such as painting at cross-walks. Prior years' projects occurred in Bettendorf and Davenport. This is the last year Bi-State Regional Commission will participate in the physical activity access program.
- 5. <u>Public Comments</u> There were no public comments.
- 6. Other Business. Ms. McCullough noted that staff was assisting with Illinois Transportation Enhancement Program grants for Annawan and Rock Island, and was made aware of applications being submitted by Geneseo, Moline, Rock Island, and Silvis. Staff also assisted with letters of concurrence and/or served inquiries for information. Mr. DeLille noted that next year's Safe Routes to School grants will allow projects to include high schools. The Committee was directed to the following list of upcoming grants for Iowa or Illinois jurisdictions related to safety, air quality emission reduction and transportation alternatives. To continue to plan for resilience of the transportation system, it was noted that September is National Preparedness Month.

- 7. <u>Adjournment.</u> Mayor Gallagher asked for a motion to adjourn. Mr. Ortiz motioned to adjourn the meeting. Mr. Dunn second the motion, and the meeting adjourned at 12:30 p.m.
